A graphic design company is in the process of developing a design of the postcard.

The Committee dialogued on further promotional activities that would either promote and/or raise funds for the Foundation. Some concepts discussed were:

- Approach a food retailer for a \$2.00 contribution at the cash register when customers are checking out.
- Increase presence of the Foundation at funeral homes.
- Approach the Archdiocese of Kingston of the possibility of having parishes, if they were so inclined, to allow parishioners to donate to the Foundation during Education Week.
- Promote planned giving and it was suggested that Wilkinson and Company could provide an overview to Trustees and the Foundation Board regarding the concept of what planned giving means (estate planning).
- Require key messaging "emotional tag" that resonates with the public, so they may consider giving to the Foundation.
- A tie in to the Foundation for students as part of their 40 hour volunteer hours.
