5. Chair's Report

Some key highlights of the year are:

- The Director of Education, David DeSantis continues to promote and strengthen our relationship with the United Way agencies to have payroll contributions directed to the Foundation by Algonquin and Lakeshore Catholic District School Board employees.
- Enhancing communication to the school system and the community in profiling the Foundation.
- The Emergency Response Fund continues to enable school administration to make application for those students and their families who are in need. Over the past school year, the Foundation has provided assistance to 111 students and their families totaling over \$53,085.
- The "Kids Helping Kids" campaign was established in 2008 and this system-wide event raised over \$6,612 in the spring of 2019.
- In August 2019, the Algonquin and Lakeshore Catholic District School Board held its annual Director's Charity Golf Tournament and \$18,205. was raised. The proceeds of that tournament were presented to the Foundation at the regular Board Meeting of the Algonquin and Lakeshore Catholic District School Board on September 24, 2019.
