## 4. Treasurer's Update - YTD Financials for 2020-21

Ms. Bradshaw shared the Statement of Financial Position as at September 28, 2020 and the Revenue and Expenditure Report Summary for the period of April 1, 2020 – September 28, 2020.

## Fundraising

Mr. DeSantis updated the Directors on the status of the foundation due to the pandemic. The golf tournament which usually raised an average of \$30,000 was cancelled due to the pandemic and the foundation banquet has also been postponed. It has been suggested that a Committee be formed to organize an online silent auction to help raise funds for the foundation. It is suggested that planning begin now for the silent auction to take place in November through December as people could purchase items as Christmas gifts. The Director's Office will assist the Committee with the promotion and launch of the silent auction. Terry Shea, Tom Dall, Brian Evoy, Kathy Turkington, Greg Speagle and Bonnie Campbell have volunteered to sit on the Committee. The Director will send out a message to all staff asking for volunteers for the Committee and the Director's Office will schedule the first meeting sometime next week.

## 6. Report of the Emergency Response Fund 2019-20 & 2020-21

The Treasurer provided a summary report on the Emergency Response Fund for the school year 2019-2020. The foundation provided assistance to 117 students and their families in the amount of \$43,446.00. For the 2020-21 school year commencing September 1, 2020, the Foundation has provided financial assistance to 11 students and their families (9 elementary and 2 secondary). The requests for assistance for the school year 2020-21 total \$4,987. The balance of funds to be disbursed is currently awaiting documentation to finalize the disbursement of funds.
